Thank you for choosing AH PROPERTIES. In order to complete the application process quickly, be sure to read this completely and follow all necessary procedures.

THINGS YOU WILL NEED TO SUBMIT WITH THE APPLICATION

APPLICATION CHECKLIST:

- 1. Completed and signed application for each person over 18 years of age who intends to occupy the residence.
- 2. Copy of valid Driver's License from each applicant, or valid picture ID.
- 3. Proof of income from each applicant: Your two most recent pay stubs.
- 4. Non-Refundable application fee of \$50 per adult, and \$500 Earnest Money. Only cashier's checks or money orders will be accepted. If your employer uses 'The Work Number' for employment verification there is an additional \$20 application fee per applicant requiring this service.
- 5. Additional documentation may be requested from an applicant depending on individual circumstances.

AH PROPERTIES will process your application upon receipt of the **completed** application plus all copies of required documents. If your application is accepted, your property manager will make an appointment with you to sign the lease contract.
